If a Change of Control (as defined in the Issuer's 2007 Stock Plan) occurs, all of the restricted stock units then unvested as of the date of the Change of Control, will vest immediately prior to the consummation of the Change of Control transaction.

2. 100% of the shares shall vest and become exercisable on June 6, 2014 so long as the reporting person's Continuous Service Status (as defined in the Issuer's 2007 Stock Plan) continues. If a Change of Control (as defined in the Issuer's 2007 Stock Plan) occurs, all of the Shares underlying this Option then unvested as of the date of the Change of Control, will vest and become exercisable immediately prior to the consummation of the Change of Control transaction.
